



will be put in the sewer and then blocked off. Once the pond is ready then they will open the sewer back up and the water will fill the pond back up. Commissioner Mahoney suggested talking with the Village about the shoreline. Commissioner Salaba asked if there is a way to section off the pond so in the winter there can be an ice rink. Paul will look into that option for the pond.

**Recreation Center** – The Board and Staff discussed the upcoming parking lot renovation, the possibility of changing the front desk configuration and viewed the condition of pre-cast gym walls. Paul Fyle explained where the turnaround will be at the Rec Center. Commissioner Salaba asked what the down time for members will be? Paul responded that it should still only be one week but will know more once he receives a schedule closer to the date. Also discussed was tossing around the idea of reconfiguring the front desk. This will be something to bundle together for the PARC grant. Executive Director, Bill McAdam thanked Kevin Rozell for doing such a great job in his new role at the Rec Center. He also mentioned since Kevin has been there the air conditioning and ducts have been cleaned. Kevin Rozell showed the Board and Staff some cracks on the pre-cast walls outside that is causing some seepage in the gymnasium. He also mentioned that the architect has been out to look at the areas and that there are no structural issues and the cracks can be caulked.


