Commissioner Comments – Commissioner Kotula mentioned that there was an article in the Chicago District Golfer on the rebranding to the Belmont Golf Club.

Commissioner Dahlstrom wished everyone happy holidays and mentioned that this is time to recharge, refresh, and reflect. Enjoy this time with family and friends.

STAFF AND COMMITTEE REPORTS

Executive Director – Bill McAdam, Executive Director, mentioned that the state legislator has clarifications to the Safe-T act, Bill will send out information. We do have a meeting scheduled for January 5th but there is nothing on the agenda as of yet. Bill had a conversation with President, Cathy Mahoney talking about how we post our documents/meetings through our website. Dawn and Adine are searching the abilities through BoardPaq. We will have this rolled out in January. Bill wished everyone a Merry Christmas and Happy New Year

Recreation – Director of Recreation, Dave Haring, mentioned that the first day of registration for the Winter/Spring programs was on Monday. The amount on Monday was \$196,000. Last year the amount on the first day was \$145,000. Our programs are in demand and everything went smooth.

Marketing - Director of Marketing and Community Engagement, Dawn Hartman, discussed that there will be new welcome signage that we are planning to install as part of the new diversity, equity and inclusion initiative. This is an effort to welcome all visitors to the Park District facilities and parks. Commissioner Dahlstrom asked if we had signage for the rebranding of the golf course and Gelwicks Park? Dawn responded that Paul Fyle and his team are working on Gelwicks Park signage and both have quite a lead time and thinking early Spring. Kevin Rozell is working with Ken McCormick on the new exterior letters at the Golf Club. Commissioner Dahlstrom thought having some LED lights behind the letters on the side of the Golf Club so it lights up at night and in the morning.

Planning & Construction - Director of Planning and Construction, Paul Fyle, updated the Board on the work going on at McCollum. They started widening the pathway at the south end of the park but with cooler temperatures, asphalt will not be available. They are hoping to put a layer of asphalt on the tennis courts on Monday. Paul also requested the Board's verbal approval to pay F.H. Paschen for work completed in October at the Golf Club. The Board gave concurrence on paying this bill.

Parks and Facilities – Director of Parks and Facilities, Kevin Rozell, discussed that the Parks were shut down and winterized. We are starting to construct ice rinks next week at McCollum and Whitlock Park. Kevin also mentioned that the beaver activity at Lyman Woods has been non-existent the last couple of months.

Human Resources – Director of Human Resources, Marian Olund, mentioned that she is still implementing the new HRIS system. It is going incredibly well. Commissioner Dahlstrom asked if the program was on-time? Marian responded that yes, for the most part it was on-time and she is very pleased with the new system.

Finance & IT – Director of Finance & IT, Erik Brown, discussed that Chris Kapus is preparing information for the Cyber Liability Coverage and will be submitting to PRDMA for approval.
