# 2022 AUDITION FORM

This is a no-cut audition process; we are open to dancers of all levels and experiences! The primary reason for holding auditions is to meet the interested dancers and see how they might work together. Depending on the number of dancers auditioning and different skill levels, dancers may be split into groups, or we might offer the chance for dancers to participate in more than one dance. During the audition process, dancers will learn and perform a short combo, as well as demonstrate basic skills and techniques. Parents & dancers will be notified of Team arrangements by April 29.

We plan to take a step back from competitions in the 2022-2023 season and focus on community performances; however, if you are very interested in competitive opportunities, please let Anna know – email her at [afontanetta@dgparks.org](mailto:afontanetta@dgparks.org).

Regularly scheduled practices will not begin until September; registration for fall practices will open in July. During the summer, dance team members will be asked to take part in at least one weekly class (not a camp), plus at least two summer workshops.

It is always advisable, especially if the participant is pregnant, suffers from an underlying medical condition, or has recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity.

I recognize and acknowledge that there are certain risks of physical injury to participants in these programs/activities, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in these programs/activities against the District, including its officials, agents, volunteers and employees.
